## **JARPD MARKET NIGHT CONDITIONS OF USE**

1. Each vendor will have an assigned booth space and must stay with that booth space provided by the organizers. Vendors may not switch spaces with another vendor unless approved by the event organizer
2. All vehicles must be removed from the market area by 4:30pm. Vendors may not drive their vehicle to their assigned space after 4:30pm to unload.
3. Vendors may not remove barricades or cones once the market concludes at 8pm to bring their vehicles in. Event staff will announce when vendors can bring in their vehicles to pack up their belongings.
4. Food vendors cannot take orders after 8pm. Food kitchens can only remain open after 8pm for orders that were placed before 8pm and still awaiting fulfillment from customers.
5. All vendors must be out of the parking lot by 10pm as parking lot gates will close at 10pm.
6. No unauthorized individuals may staff the vendor's booth. Authorized individuals will be those who have completed and signed the vendor application and the agreement, waiver, and release form.
7. Vendor booth area must be kept in clean and safe condition. Each vendor is responsible for cleaning their booth at the end of the event.
8. Food items must always be handled and served in sanitary conditions.
9. All health codes must be observed.
10. Each vendor is authorized to only sell approved items. Additional items cannot be sold without prior approval.
